**Tuition and fees to be paid in four equal installments on the following schedule:**

- \$ 50 non-refundable registration fee is due with application
- \$1675 submitted upon acceptance of enrollment application
- \$1675 submitted on or prior to the 1st month of class
- \$1675 submitted on or prior to the 2nd month of class
- \$1675 submitted on or prior to the 3rd month of class

**Cancellation And Refund Policy**

A 100% refund shall be made if the student officially withdraws prior to the first day of class. Also, a student is eligible for a 100% refund if the class in which the student is officially registered is canceled by the school. A 75% refund of tuition shall be made if the student officially withdraws from the class(es) prior to or on the 10 percent point of the term. A student who officially withdraws after 10% of mark is not entitled to a refund. Registration fee is non-refundable.

**PRIMARY BENEFIT OF PROGRAMS:** Programs are avocational - designed for recreational, self improvement, or continuing education of occupationally qualified individuals. Avocational programs do not fall under any board of education oversight.
